### 4. PUBLIC COMMENT SESSION

Fire Chief Mark Green asked who the new Outagamie County Sheriff Deputy for Freedom was. Supv. Brandon Conrad announced that Clay Paulson had been chosen. The Fire Department and EMS will be notified in the future when a change occurs.

Fire Chief Green discussed that they had not moved everything out of the fire garage. The board was ok with giving them a month to finish removing everything that was remaining. Temporarily the items in the old fire garage can remain.

Mark Green will work with clerk on the maintenance agreements and supplies needed for the new fire department.

Sam Van Handel expressed concerns about Monday night's meeting of why the no board members were present for the interviews of the deputy clerk's position.
