**3. DISCUSSION AND CONSIDERATION OF FIRE DEPARTMENT CONTRACT**

After much discussion about the Fire Department budget the Town Board along with Attorney Steve Frassetto asked the Fire Chief to create a five-year capital improvement plan. This would give the Town Board a better understanding of future capital expenses and would help the Board to better understand what expenses are fixed. This information would help greatly when budget time rolls around.

The Fire Department brought up that they are having a problem with insect control which led to a discussion on who would be responsible for paying those cost. Supv. Brandon Conrad instructed Clerk Laha to schedule a meeting between Fire Chief Mark Green and Wil-Kil to get a quote for insect and rodent control. Attorney Steve Frassetto stated he would add verbiage to the Fire Department Agreement with the Town to pay all maintenance on the building. It was also brought up that there should be something in the agreement about the Town providing an adequate facility for the fire department. Attorney Frassetto will take care of adding this to the agreement as well.
