3. CONSIDERATION OF HIRING EMPLOYEES

These two options were discussed: hiring a full-time employee to share job responsibilities between the parks and highway departments, or whether it would be more beneficial to hire a public works director/field worker who would split his time evenly between office and field time.

4. CONSIDERATION OF EQUIPMENT PURCHASE – TRACTOR/MOWER

A discussion was held about purchasing a new tractor with attachments as well as a new mower. The cost to purchase the tractor with attachments from Riesterer & Schnell is \$143,000.00 They offered \$58,650.00 for trade in value on the town's current tractor. So, the total cost of the tractor after the trade-in would be \$84,652.00. The cost for the Diamond mower was bid at \$18,643.46. After discussing all the options, the Town Board made a decision to purchase the Diamond mower from Riesterer & Schnell at a cost not to exceed \$18,750.00 and to postpone the purchase of a tractor for now.
