The current pumper truck is at least 20 years old and is due to be replaced. The Fire Department explained that this new truck has many updated safety features. The cost of the new Build-to Order Pierce Velocity Rescue Pumper is \$907,203.00. Financing options were discussed, but no decision was necessary at this time. There is a 14-16 month lead time. A purchase order will be needed before the price increase which takes place February 1, 2022. It is estimated that the current pumper is worth \$25,000.00. 4.
