1. CALL TO ORDER, ROLL CALL, INVOCATION, PLEDGE

Meeting called to order by Chairman Charles Kramer at 7:01 p.m.

Members present: Supervisor Jason Vandenberg, Supervisor Brandon Conrad and Supervisor Margo Fox. Also present: Clerk/Treasurer Colleen Laha, Attorney Steve Frassetto, and Dean Zanon from Cedar Corporation.

Supervisor Brandon Conrad led in the Pledge of Allegiance.

2. VERIFICATION OF POSTING/ADOPT AGENDA

Posted on the 2 Boards at the Freedom Town Hall and on the Town website on the 12st day of July, 2022 at 2:30 p.m. by the Clerk's Office. Also posted at: Dairyland Depot, Freedom Mini Mart and Shop & Save Mart/ Halesi, LLC.

3. DISCUSSION & ACTION ON THE COUNTRY FIELDS SUBDIVISION PROJECT START, DEVELOPERS AGREEMENT AND ENGINEERING

Country Fields Subdivision Developers furnished the Town with a letter of Financial Guarantee/Approval. Approval from the Drainage Board has been received. Country Fields Subdivision Project has a tentative start date of July 25.

Attorney Steve Frassetto reviewed the Developers Agreement that incorporated all the comments forwarded by Cedar Corp. They will be requiring all contractors to have the insurance requested to work on the property. Steve did not include completion dates for the various infrastructure components. Frassetto will work with the developers for input. Dean Zanon from Cedar Corporation went over the rates: storm sewer/road for the Town – observation rate: \$95.00 - \$105.00 per hour. General Project Administration rate: \$115.00 -\$135.00 per hour. The Agreement is worded so that whatever Cedar or the WDNR charges to the Town and the District would get passed on to the developer. The developer Jason Vandenberg discussed that Davel Engineering was only charging \$45.00 per hour and McMahon charges \$52.00 per hour for the same thing. Dean Zanon explained that Cedar Corporation would not change their charges. Zanon did agree that if the two parts of the project were being done at the same time (example – if storm drains and sewer and water were being installed at the same time), Cedar Corporation would not double charge. Supervisor Margo Fox did not feel comfortable with the developer's engineer observing and giving final approval of the construction. Supervisor Brandon Conrad said his stance is that Cedar Corporation is hired by the town to do the inspections, engineering, and planning. These are our people and we have them under contract. Jason Vandenberg also commented that because the Town is under County Zoning, so the developer is also getting charged by County and more red tape.

Motion by Supervisor Brandon Conrad with second by Supervisor Margo Fox to approve the developer's agreement for Country Fields Subdivision with a project start date of July 25, 2022, with the conditions contingent that 1.3 completion dates are subject to Town Attorney, Town Engineer and developer approval and contingent on 4.2 the inclusion of the Construction Observation fee rates that will range from \$95.00 to \$105.00 per hour and General Project Administration rate from \$115.00 - \$135.00 per hour.
