BelGioso is working with the Sanitary District on the feasibility of having a sanitary bypass from the new WWTP to the existing 8-inch sanitary main in the to be vacated Spring View Court.

9. CONSIDERATION OF SITE PLAN APP # SP3-04-19-15 - FIC PROPERTIES

Engineer Steve Brueggeman gave update on FIC Properties. Plan Commission was supposed to be on 4/17 and FIC would wait with construction until after that meeting. Due to not having an available quorum, the Plan Commission meeting was cancelled and moved to after Town Board meeting. Family Insurance approached Steve asking to start early, Steve said they cannot proceed without Plan Commission approval. Steve recommended that FIC contact the Town Chairman. Town Chairman Charles Kramer came in the next day and said if FIC meet all the criteria and Steve said it did, but also said it did not go to plan commission. Steve said it still needs site plan approval form plan commission and town board prior to typically allowing a building permit. Kramer told Steve to let FIC know that they can proceed with Chairman's verbal approval.

Mark Dollevoet said they actually got a building permit this time so that's good, a good start. Henry McKenna also mentioned that it did not meet our approval and Steve said that is correct. Steve also had suggested that the Town Board put FIC on the agenda to approve at last night's meeting and Plan Commission would just review so FIC can go ahead. Kramer did not want to do this and he sets the agenda for the Town Board. Steve had told FIC they couldn't do any outer work on the building until they got a permit.

Henry understood the process but not comfortable with being overpowered. Steve said he heard from Barb that Chairman Charlie contacted two plan commission board members. Dan and Ron said they were contacted by Chairman Charlie.

Motion by Comm. Mashlan with second by Comm. Dollevoet to recommend approval of the Site Plan for FIC Properties with the following conditions:

- 1. Applicant to coordinate location of Knox Box with Town of Freedom Fire Department upon obtaining of building permit.
- 2. No proposed mounted signing is being shown. Any modifications to the existing ground mounted sign or any new signs that will be constructed need to be submitted for review and approval prior to issuance of the building permit.
