BE IT FURTHER RESOLVED, that upon passage and posting or publication, as required by law, the Town Clerk is hereby directed to file a copy of this Resolution in the Outagamie County Register of Deed's Office.

Thence along said curve 208.99 feet, said curve turning to the right, having a central angle of 51° 23' 33", having a radius of 233.00 feet, and whose long chord bears S 64° 51' 06" E for a distance of 202.06 feet;

Thence along said East line, S 39° 09' 19" E, 292.18 feet to the beginning of a curve;

Thence along said curve 157.32 feet, said curve turning to the right, having a central angle of 38° 41' 08", having a radius of 233.00 feet, and whose long chord bears S 19° 48' 45" E for a distance of 154.35 feet;

Thence along said East line, S 00° 28' 11" E, 572.96 feet to the beginning of a curve;

Thence along said curve 107.14 feet, said curve turning to the left , having a central angle of 08° 00' 13", having a radius of 767.00 feet, and whose long chord bears S 04" 28' 24" E for a distance of 107.05 feet to the beginning of a curve;

Thence along said curve, 95.96 feet, said curve turning to the right, having a central angle of 06° 36' 02", having a radius of 833.00 feet, and whose long chord bears S 05° 10' 23" E for a distance of 95.91 feet;

Thence, S 45° 49' 52" E, 70.85 to the North line of C.T.H. "S": Thence, S 89° 31' 49" W, 167.97 to the West line of Meadow Hill Drive;

Thence along sald West line, N 44° 10' 47" E, 73.24 feet to the beginning of a curve;

Thence along said curve 84.42 feet, said curve turning to the left, having a central angle of 06° 18' 23", having a radius of 767.00 feet, and whose long chord bears N 05° 19' 12" W for a distance of 84.42 feet to the beginning of a curve;

Thence along seid curve, 50.29, said curve turning to the right, having a central langle of 03° 27' 33", having a radius of 833.00 feet, and whose long chord bears N 06° 44' 38" W for a distance of 50.28 feet to the South line of Spring View Court; Thence along said line, S 89° 31' 49" W, 278.39 feet to the beginning of a curve;

Thence along said curve 62.45, said curve turning to the left, having a central angle of 39° 45' 30", having a radius of 90.00 feet, and whose long chord bears S 69° 39' 04" W for a distance of 61.21 feet to the beginning of a curve;

Thence along said curve 317.05 feet, said curve turning to the right, having a central angle of 259° 31' 00", having a radius of 70.00 feet, and whose long chord bears N 00° 28' 11" W for a distance of 107.62 feet to the beginning of a curve;

Thence along said curve 62.45 feet, said curve turning to the left, having a central angle of 39° 45' 30", having a radius of 90.00 feet, and whose long chord bears S 70° 35' 26" E for a distance of 61.21 feet to the North line of Spring View Court;

Thence, N 89° 31' 49" E, 275.77 feet to the West Line of Meedow Drive;

Thence along said West line, N 00° 28' 11" W, 326.74 feet to the South line of Soua Court;

Thence along said South line, S 89° 27' 08" W, 117.88 feet to the beginning of a curve;

Thence along said curve, 49.30 feet, said curve turning to the left, having a central angle of 43° 27' 15", having a radius of 65.00 feet, and whose long chord bears S 67° 43' 30" W for a distance of 48.12 feet to the beginning of a curve

Thence along said curve, 326.09 feet, said curve turning to the right, having a central angle of 266° 54' 30", having a radius of 70.00 feet, and whose long chord bears N 00° 32' 52" W for a distance of 101.63 feet to the beginning of a curve;

Thence along said curve 49.30 feet, said curve turning to the left, having a central angle of 43° 27' 15", having a radius of 65.00 feet, and whose long chord bears S 68° 49' 14" E for a distance of 48.12 feet, to the North line of Soua Court;

Thence along said North line, N 89° 27' 08" E, 117.97 feet to the West line of Meadow Hill Drive;

Thence along said West line, N 00° 28' 11" W, 180.22 feet to the beginning of a curve;

Thence along said curve 112.76 feet, said curve turning to the left through, having a central angle of 38° 41' 08", having a radius of 167.00 feet, and whose long chord bears N 19° 48' 45" W for a distance of 110.63

Thence along said West line, N 39° 09' 19" W, 292.18 feet to the beginning of a curve;

Thence along said curve 149.79 feet said curve turning to the left, having a central angle of 51° 23' 33", having a radius of 167.00 feet, and whose long chord bears N 64° 51' 06" W for a distance of 144.82 feet;

Thence S 89°27' 08" W, 637.24 feet to the POINT OF BEGINNING.

Said parcel contains 200625 square feet, or 4.61 acres +/-.
