PERMIT CONDITIONS/SPECIAL PROVISIONS

- 1) The owner or representative shall notify the Department of Public Works at (920) 788-4548 a minimum of 48 hours prior to beginning any work in the public right-of-way and within 5 days of completion of work.
- 2) The applicant, his successors, or assignees agrees to indemnify and hold harmless the Town of Freedom, its employees and representatives against any and all liability, losses, damages, or expenses sustained by reason or exercise of this permit.
- 3) No road closures are permitted without the permission of the Director of Engineering & Public Works.
- 4) The permittee shall furnish proof of public liability insurance of not less than \$100,000 for one person, \$300,000 for one accident and property damage insurance of not less than \$50,000.
- 5) No opening in the roads or sidewalks for any purpose shall be permitted when the ground is frozen, except as determined necessary by the Director of Engineering & Public Works.
- 6) Pavement patches shall be replaced in kind, minimum of 12 inches of crushed aggregate base course, 2 inches of lower layer asphaltic pavement, 1-1/2 inches of upper layer asphaltic pavement compacted in place. Cold mix in winter (temporary) shall be replaced with hot mix asphalt in spring by June 1st.
- 7) Sidewalks and driveways shall be replaced in kind. Sidewalks shall be 4 inches concrete over 4 inches crushed aggregate base course. Driveways shall be 6 inches concrete or 4 inches asphalt pavement over 6 inches crushed aggregate base course.
- 8) All replacement items shall conform to the Town of Freedom Street Specifications.
- 9) Any roadway surfaces, slopes, shoulders, ditches, and vegetation disturbed shall be restored.
- 10) Traffic control warning signs, devices, and methods shall be in place and operational prior to commencing permitted works within the limits of the right-of-way.
- 11) Warning signs and devices, and highvisibility safety apparel that are required shall conform of the Wisconsin Manual on Uniform Traffic Control Devices (MUTCD), current edition.
- 12) All restoration shall be completed within 30 days of project completion. After 30 days, the Town reserves the right to complete the restoration work at the permit holder's expense.

Other Special Provisions
