Budget Hearing called to order at 6:00 p.m.

Board members present: Chairman Tim Maass, Supervisors Steve Lowney, Don Gonnering, Pam LaPlant and Gabrielle Radford. Also present: Clerk Barb Seegers and Adm Asst Laha. Six residents were in attendance. Posted November 3<sup>rd</sup>, 2009 at the Freedom Town Hall, Freedom Mini Mart, Dairyland Depot, Shorty's One Stop, Freedom Foods.

Maass reviewed the main points and changes in the budget: all budgets (police, fire and administrative) were frozen because of the economy; highway dept. budget was cut by \$30,000, state revenue reduced by \$30,000, senior center budget increased from \$6,000 to \$25,000, debt retirement fund increase by \$31,707, and estimated \$12,000 increase in state land fill tipping fees.
